Pricing Notes

Overtime premium rates are applicable after 8 hours per day Monday to Friday, all day Saturday, Sunday and holidays. Regular working hours are Monday - Friday 0730 - 1630. There is no overtime charged on trucking or Jack and Slide.

Our mob/demob includes all costs associated with providing the crane, counterweight loads and labour to site. Any delays caused by circumstances beyond the control of REVOLUTION (i.e. gate entrance delays, special testing, training, road closures) will be billed at the applicable rates.

Supervisors/riggers, if required to assist during hoisting operations as assemble rigging, will be charged at the applicable rate provided in the quote.

All pricing subject to approvals on access and permits to position the crane on site.

Payment terms are NET 30

General Terms and Conditions

All pricing is **estimated only** and is subject to the verification of all preliminary information. Equipment sizes and configurations may be subject to change upon the introduction of any new or updated information.

This proposal is subject to the availability of manpower and equipment at the date and time of project execution.

Client to provide any necessary or applicable onsite orientations pursuant to the work activities (which is not included in the quoted price).

Ground conditions and suitable site access are the responsibility of the client. Damages to third party properly incurred during site access, rig up/down and operation remain the responsibility of the client. REVOLUTION **will not** be responsible for any possible damages that may occur to parking lots, sidewalks, roadways, grass/landscaping, curbs or pedestrian/traffic control.

Customer to supply adequate access, room, and ground conditions free of charge for equipment transportation and set up. This is known as "Free and Clear Access".

The provision of any part of the Scope of Work contemplated in this quote is subject to REVOLUTION confirming in writing, after this offer is accepted by the Client, that REVOLUTION has equipment available to perform the entire Scope of Work.

This proposal is based on weight and dimension information provided at the time of tender by the client and is subject to change after our review of the final technical details, including centre of gravity.

REVOLUTION reserves the right to conduct a final inspection of the work area to verify the crane will be on good ground conditions and is within working radius of the crane prior to the mobilization of the equipment.

If Jack and Roll/Slide work is to be performed as part of this quote, then the customer is to provide, at no cost to REVOLUTION, work areas with a solid compacted base, and free and clear access directly adjacent to the work areas.

Specialized lifts or critical lifts will be supervised and co-ordinated by REVOLUTION unless competency of customer supplied lift/planning supervisors is verified by REVOLUTION.

REVOLUTION will bill for any weather related delays, detours, or excess wait times beyond (1) hour (due to customer) at the hourly rates posted above.

REVOLUTION crew and equipment will receive the same working time as project site personnel.

Loads must have adequate, engineered lift points for balanced hoisting and must ensure structural integrity of the load with lift points provided.

REVOLUTION equipment transportation is based on full legal transportation weights (no road bans). Unless otherwise noted! Additional charges may apply during road ban season.

Any delays caused by circumstances beyond the control of REVOLUTION (i.e. special testing, training) will result in extra charges for labour and equipment.

All 3rd Party Utility, engineering and permit costs are at an extra cost to the customer plus 10%.

All applicable taxes are charged extra.
